

# **Boil Water Notice for Community Public Water Systems**

## **8/2/2025**

### **NOTICE TO RESCIND BOIL WATER NOTICE**

On **July 31, 2025**, the Texas Commission on Environmental Quality (TCEQ) required **Brashear Water Supply Corporation**, public water system #1120010, to issue a **Boil Water Notice (BWN)** to inform customers that due to a **broken water line feeding into our system**, the water from our system had to be **boiled prior to consumption**.

We are pleased to report that **the issue has been corrected** and that **follow-up water quality testing confirms** that the water no longer requires boiling. As of **August 2, 2025**, the Boil Water Notice is **officially rescinded**.

### **AVISO DE CANCELACIÓN DEL AVISO DE HERVIR EL AGUA**

El **31 de julio de 2025**, la Comisión de Calidad Ambiental de Texas (TCEQ, por sus siglas en inglés) exigió a la **Corporación de Abastecimiento de Agua de Brashear**, sistema público de agua #1120010, emitir un **Aviso de Hervir el Agua** para informar a los clientes que, debido a una **línea de agua rota que alimenta nuestro sistema**, el agua debía ser **hervida antes de su consumo**.

Nos complace informar que **el problema ha sido corregido** y que las **pruebas de calidad del agua confirman** que ya **no es necesario hervir el agua**. A partir del **2 de agosto de 2025**, el Aviso de Hervir el Agua queda **oficialmente cancelado**.

Due to a broken water line feeding into our water system, the Texas Commission on Environmental Quality has required the Brashear Water Supply public water system to notify all customers to boil their water prior to consumption (e.g., washing hands/face, brushing teeth, drinking, etc). Children, seniors, and persons with weakened immune systems are particularly vulnerable to harmful bacteria, and all customers should follow these directions).

To ensure destruction of all harmful bacteria and other microbes, water for drinking, cooking, and ice making should be boiled and cooled prior to use for drinking water or human consumption purposes. The water should be brought to a vigorous rolling boil and then boiled for two minutes. In lieu of boiling, individuals may purchase bottled water or obtain water from some other suitable source for drinking water or human consumption purposes.

When it is no longer necessary to boil the water, the public water system officials will notify customers that the water is safe for drinking water or human consumption purposes.
